RE: Clarifying rights in the Alberta Human Rights Act

Honourable Jonathan Denis, Minister of Justice and Solicitor General:

The Trans Equality Society of Alberta (TESA) formally requests that the *Alberta Human Rights Act* be amended to make "gender identity" and "gender expression" explicitly stated as prohibited grounds for discrimination in Alberta.

Acknowledging that the *Act* establishes that "it is recognized in Alberta as a fundamental principle and as a matter of public policy that all persons are equal ..."[1] TESA notes that all too often, our members continue to learn of difficulties encountered by trans* Albertans who are unsuccessful in fully experiencing this equality.

TESA's mission is to be a witness and a voice for matters concerning trans* Albertans. Although the Alberta Human Rights Commission lists "transgender" as being protected in Alberta,[2] and the Government of Alberta states that "[d]iscrimination on the basis of gender identity is a violation of human rights legislation,"[3] this ground is protected by inference from other grounds currently enumerated within the *Act*. TESA believes that clarifying the *Act's* reference to "all persons" as including persons without regard to their gender identity and gender expression would help all Albertans uphold this fundamental principal and public policy.

At this time, the respective Acts or Codes of the Northwest Territories[4] and Manitoba[5] have chosen



to make trans* inclusion in human rights explicit through the clear inclusion of the ground "gender identity," while the provinces of Ontario[6], Nova Scotia[7], PEI[8], and Newfoundland and Labrador[9] have chosen to make the grounds of both "gender identity" and "gender expression" explicit.

TESA believes that adding "gender identity" and "gender expression" to the *Alberta Human Rights Act* is a reasonable and justifiable step toward ensuring trans* Albertans enjoy full equality within our province. TESA appreciates your consideration of this request, and looks forward to your response.
